Covid-19 Vaccine Update – What You Need To Know!

PCR Test Hoax

First, the FDA Document Admits that the "Covid" PCR Test was developed without isolated Covid-19 samples for Calibration of the test. Effectively, the FDA is admitting that the Covid-19 PCR test is testing for something else rather than Covid-19.¹

The Covid-19 PCR test is a hoax. It does not work and the technology is inappropriate for a test. The inventor of the PCR, Kary Mullis, said that it can not be used to determine if anyone is infected with a virus. In the 1980s they were trying to use the PCR to develop an HIV test. Kary said

In short he stated: "these tests [PCR] cannot detect free, infectious viruses at all; they can only detect proteins." ² This is why the CDC will no longer be using the PCR test as of the end of December 2021 but the truth is they should have never used it and shouldn't be using it now.

Fraudulent Death Reporting

Many experts speculated that many of the Covid-19 deaths were actually flu deaths. When the 2020-2021 flu death statistics came out, speculation

seemed to be confirmed. Flu deaths decreased by 97%. The 2018-2019 flu season had approximately 34,000 deaths. The 2019-2020 flu season had approximately 22,000 deaths. But during the Covid-19 outbreak, flu deaths dropped to just 600.³

The Covid-19 death toll is fraudulent. It is utterly amazing how deep the fraud goes. The fraud most likely involves many thousand of who did false reporting including government officials, doctor, nurses and hospital administrators in almost every town in the US. If someone died, they gave them a Covid test that doesn't work. They could manipulate the

test to make someone test positive. If they tested positive for Covid-19, then Covid-19t was the cause of death. It didn't matter if they died from a gun shot, or were in a car accident or were in hospice care and died from cancer or any of many other causes, Covid was listed as the cause of death. Why would people do this, corruption for one and because they got \$39,000 from the government for a Covid death.

The CDC admitted that 94% of Covid deaths had co-morbidity (other causes). The mainstream press claims that the CDC's revelation regarding co-morbidity doesn't change the actual death toll but this is a

Another cause of Covid deaths is that patients were not treated. I listened to a doctor's testimony from Wisconsin. He was a department head and had the responsibility of establishing treatment protocols. He helped

I heard a similar story from a nurse in New York. But beyond this, sick patients were forced back into Nursing Homes in New York and Michigan and some other states as well. This caused many unnecessary Covid deaths. Further, Dr. Sam Baily reveals that many treatment trials gave lethal doses of Hydroxychloroquine and other drugs to patients

Doctors who have successfully treated hundreds or even thousands of Covid patients with almost 100% success, have been ridiculed, there

The Vaccine Is Dangerous

It is well documented that the mRNA Covid-19 vaccine changes the DNA of your cells to produce the spike protein. This DNA change is

And the spike protein remain in the area of the shoulder as well. But in Japan they have done bio-distribution research to see if the spike protein stays in the shoulder. The Bio-distribution data shows that the spike protein goes throughout the entire body including your brain and heart.

The long-term health consequence of the spike protein are totally unknown. The long-term health consequences of SV-40 were unknown as well. SV-40 is a monkey virus that contaminated the polio vaccine from 1961 until the end of the 1990s. Tens of millions of children were infected. It is known to cause cancer and the cancer rate has skyrocketed since it infected the vaccine. It has been announced that a test of the Covid vaccines revealed they were contaminated knowingly or unknowingly with substances not listed on the vaccine label. These include: Graphene, Nanometals (i.e. aluminum, titanium, vanadium, chromium, iron, nickel and copper), PEG (polyethylene glycol known as

Contaminates have been found in Japanese Covid vaccines as well. In late August 2021, Japanese officials suspended the use of a total of 2.6 million of doses of the Moderna Covid vaccine because of contaminates. Foreign substances were found in many different batches of the vaccine and two people died after receiving vaccination from the contaminated lots. 9 Interestingly, Japan is now under a state of emergency covering 80% of its population because of the Delta variant outbreaks. The mRNA Covid-19 vaccine has proven to be ineffective against the Delta variant.¹⁰

Covid Vaccine Is Killing People!!!

The CDC VAERS (Vaccine Adverse Events Reporting System) shows that vaccine related deaths rose by approximately 700% once people began receiving the Covid-19 vaccine. 11 But the actual number of vaccine related deaths in the US is a mystery. Experts claim that VAERS data represents only 1% to 10% of actual adverse events. In other words, actual deaths are 10 to 100 times higher than reported deaths. As of September 17, 2021, the CDC is reporting 15,386 deaths from the Covid vaccine 12

A whistle-blower claiming to be a CDC insider has sworn under penalty of perjury that the CDC is falsely reporting Covid-19 vaccine deaths reported to VAERS. She has seen the actual Vaccine death count which she claims to be over 45,000. Thomas Renz, an attorney based in Ohio has filed a lawsuit, on the whistle-blower's behalf. The lawsuit alleges the federal government is covering up the true number of deaths from the Covid-19 vaccines. 13 "According to Renz, there are as many as 12 different systems that report vaccine-caused deaths and injuries to the government. This means that the true number of Chinese Virus injection

deaths could be closer to 540,000 people."¹⁴ This is only an estimate since the CDC is covering up the truth.

One of the alternate reporting systems for vaccine injuries is V-Safe. The Whistleblower contends that V-Safe has even more information about the safety of the Covid vaccine than VAERS does but the CDC is refusing to make public what they know. V-Safe allows users to file adverse events regarding the vaccine in a much easier manner using their smart phone.¹⁵

The European Union is reporting, based on their vaccine injury reporting

system, that over 20,000 have died from the Covid-19 vaccine in the European Union and over 1.9 million have been injured by the vaccine, 50% seriously.¹⁶

A statistician estimated the number of vaccine related deaths as a result of the Covid-19 vaccine worldwide. He did statistical analysis of the numbers of people who have been reported to have received the vaccine around the world and reported covid death figures around the world. He estimated "that 800,000 to 2,000,000 of the COVID-19 deaths recorded are actually vaccine-induced deaths." If these figures are right, the death

rate from the vaccine is from two to five times higher than from the virus itself. The difference between the virus and the vaccine is that the virus kills almost exclusively those who are near death and the vaccine can kill healthy people as well as the sick.

The above death estimates seem to be consistent with what another researcher found. I lost track of the link to this Doctor's discussion about his research but I have the link to his data. The Doctor was going to write a paper about Covid-19 deaths and the co-factors. The Doctor pulled up a data base of over 13,000 who had been reported to have died from

Covid-19. He did analysis of the first 250 people who had died on the list. To the Doctor's utter astonishment, all 250 had received the Covid-19 vaccine. And after analyzing the available information, the doctor concluded that all 250 had died from the vaccine and not from Covid-19. Based on this, the doctor concluded that vaccine deaths were being reported and hidden as Covid-19 deaths.¹⁸

The CDC is now almost essentially admitting that they are covering up Covid vaccine deaths. Dr. Simone Gold reports: "The CDC is now listing vaccinated COVID-19 deaths as UNvaccinated deaths if they die within

Was The Vaccine Designed To Injure and Kill?

In an explosive video, Friar Alexis Bugnolo says that vaccine scientists know that anti-body priming will kill people. He predicts the Covid-19 mRNA vaccine will lead to mass deaths in the future. Dr. Dolores Cahill, professor of molecular genetics, School of Medicine at University

College Dublin is sounding the alarm as well. Dr. Cahill is not making the same dire predictions but she says it is going to be bad.

Based on animal studies, Dr. Cahil states that the time of the most severe adverse events (side effects) is when a person comes into contact with whatever was in the mRNA vaccine. In the case of the Covid-19 mRNA vaccine, your cells have been reprogrammed to produce the spike protein. When your are exposed to the spike protein from an outside source such as Covid-19, flu, or cold, your immune system learns to attack the source of the spike protein which is you. This is called an

autoimmune response (the body attacks itself). An autoimmune response can lead to many diseases or conditions including death. Dr. Cahil states: "What it does is this gene therapy or medical device is setting up an autoimmune disease chronically." Speaking of multiple annimal mRNA vaccines studies, Dr. cahil states: "what happened in the animal studies, 20% or 50% or 100% of the animals died." That is an astounding death rate!

Dr. Cahil says each additional booster shot increases your chances of having adverse reactions and increase the likely-hood that you will have

This conspiracy is supported by events of the past few decades. A "group of biowarfare experts, appearing before a United Nations panel... estimated that the cost of a largescale killing operation against a civilian population would amount to \$2,000 per square kilometer with conventional weapons, \$800 with nuclear weapons, \$600 with nerve-gas weapons, and \$1 with biological weapons." What these experts were saying is that biological weapons can kill a large civilian population at a cost savings of over 99.95% compared to conventional weapons and

99.88% compared to nuclear weapons.²⁴

"In the late 1960s, president Nixon renounced germ warfare, except for "medical defensive research." This "defensive research continues to the present time, and primarily centers around vaccine development and the **genetic engineering of infectious agents capable of infecting large masses of people.**" (Emphasis added) Personally, I see no difference in defensive and offensive research into biological weapons; they both do the same.²⁵

Nathan Gordon, former Chief of the Chemistry Branch of the Technical Services Division of the CIA testified before a US Select Committee to Study Governmental Operations with Respect to Intelligence Activities and the Unauthorized Stockpiling of Toxic Agents in 1975. He testified:

The only way admittedly, and unequivocally, that is a large amount of material for any purposes of applying it in a lethal form to people—the only way that you could kill those large numbers of people as related to the quantity of stockpile, is, in my humble opinion, to put some of them in one long line and inoculate each and every one.²⁶

The Vaccine Is Not Effective

The theory behind vaccines are that they give you immunity against a certain disease. If they actually worked, it wouldn't matter what happened to anyone who was un-vaccinated. Yet, we are repeatedly being told that the un-vaccinated people are the cause of the problem for current Covid-19 outbreaks among the vaccinated. We are being told you still need the vaccine even if you have natural immunity – why?

A UK Aircraft carrier and it's Strike Group had a Covid-19 out-break

despite the fact that everyone had had the first and second vaccination.²⁷ Likewise, a Carnival Cruise ship had an outbreak on board; "99.98 percent of the crew was vaccinated, along with the vast majority of the passengers." In addition to being vaccinated, the crew wore N95 masks.²⁸ One of the passengers died from the virus. Could it be that vaccines are the problem?

Most universities are requiring students to be vaccinated. Duke University recently had an outbreak of Covid with 364 positive tests during random testing. It has a vaccination rate of 98%. 98% of the

Israel has a vaccination rate of 71%. "According to Dr. Haviv, the vaccinated account for 85-90% of all new hospitalizations and 95% of

people infected had been vaccinated.²⁹

"severe" cases at the Herzog Medical Center in Jerusalem." Dr. Kobi Haviv is one of Israel's leading health officials. He is the medical director of Herzog Medical Center which is Israel's leading center for respiratory care.³⁰

In June 2021, because of the increase in Covid cases, Israel closed the

border to vaccinated tourists until August 1, 2021. Apparently, Israel had no confidence that the vaccine was working.³¹

Israel is the first nation to receive the 3rd Covid booster. 1.9 million people have already received the 3rd booster or approximately 20% of the population. The result was the daily confirmed new Covid-19 cases shot through the roof to the rate of 1,000 new cases per 1,000,0000 population per day. This is the highest level since the outbreak began. On August 30, 2021, the US, with a vaccination rate of 66%, had 480 new cases per 1,000,0000 population per day. And India, with a vaccination rate of

42%, had 30 new cases per 1,000,0000 population per day. Note that India with the lowest vaccination rate has the lowest rate of new cases.³²

On September 28, 2021, Martin Foley, Health Minister of Victoria, Australia announced there were 867 new Covid cases in the previous day. Of the 867 new Covid cases, 375 people were hospitalized, 81 people were in intensive care and 61 people were on a ventilator. The mainstream media is ignoring the most important statistic, "95% of the COVID patients in Victoria hospitals are vaccinated." Of the hospitalized cases 78% are fully vaccinated, and 17% are partially vaccinated (1

dose).³³ The vaccination rate in Australia is 62% and the fully vaccinated rate is only 42%.³⁴ It looks like if you want to stay out of the hospital, the common denominator is to be unvaccinated.

On August 7, 2021, the Director of the CDC, Dr. Rochelle Walensky, stated in a CNN interview that the COVID vaccine cannot prevent the transmission of the disease.³⁵

NBC reported at the end of July that 125,000 people who had received the Covid vaccine had gotten Covid and 4,100 had died.³⁶ These statistics

80% of Americans Have Natural Immunity to Covid

If you are young, you really have nothing to fear from the Covid virus. Most people have probably already been infected. In Sept. 2021, the CDC revealed 80% of Americans have been infected with Covid. This means most people are already immune to Covid. This is twice the number than previously estimated. It also means that the death rate is half of what was previously reported by the CDC.³⁷

Natural Immunity is 13 Times More Effective Than Vaccine

Once you have had Covid, you have natural immunity. Two new studies from Israel and the UK show that those who have had the vaccine have a 1,300% greater chance of getting the delta variant than those who have natural immunity from catching the virus.³⁸ In early August a Doctor from the Herzog Hospital in Jerusalem, Dr. Kobi Haviv, revealed a startling truth: "95% of the severe [Covid] patients are vaccinated". "85-90% of the [Covid] hospitalizations are in fully vaccinated people." "The effectiveness of the vaccine is waning/fading out". 39 The question is, does the vaccine lower or destroy your natural immunity?

The Vaccine Approval Hoax – What They Are Not Telling You

It has been widely reported that the Pfizer Covid vaccine received full approval from the FDA. The reports have been completely misleading or even false. The Pfizer-BioNTech COVID-19 vaccine received Emergency Use Authorization (EUA) from FDA on December 11, 2020.

This EUA was reissued on August 23, 2021. The vaccine which was approved is the BioNTech Manufacturing GmbH for <u>COMIRNATY</u> (<u>COVID-19 Vaccine</u>, <u>mRNA</u>). This is a different vaccine and all indications are that it is not currently available and it seems uncertain when it will be available. Some reports state it won't be available for two years.

The FDA letter reissuing the EUA for the Pfizer-BioNTech COVID-19 vaccine States: "There remains, however, a significant amount of PfizerBioNTech COVID-19 vaccine that was manufactured and labeled

in accordance with this emergency use authorization...". The letter further indicates that the vaccine expiration dates have been extended. Therefore, it can be concluded based on this information that anyone choosing to get the vaccine or forced to get the vaccine will not get the approved vaccine for some indefinite period of time but instead will get the experimental vaccine. 40

In an article in *The Defender*, Robert F. Kennedy jr. and Dr. Meryl Mass write: "The press reported that vaccine mandates are now legal... the FDA acknowledges that while Pfizer has "insufficient stocks" of the

But only EUA-authorized vaccines, for which no one has any real liability, will be available during the next few weeks when many school mandate deadlines occur. The FDA appears to be purposefully tricking American citizens into giving up their right to refuse an experimental product."41

I have read from several sources, that I believe to be reliable, that the <u>COMIRNATY (COVID-19 Vaccine, mRNA)</u> will not be available in the US until 2023. I have not been able to confirm this in FDA documents I have been able to find. Although these other source have shown documents that show a footnote that reveals a 2023 Comirnaty availability date.

Vaccine Mandates Are Illegal For Experimental Vaccines

The mRNA Covid-19 Vaccine and other Covid-19 vaccines are still

experimental although they have emergency use authorization. Because they are experimental, they fall under the Nuremberg Code for Medical Experimentation.

The Nuremberg Code established the rules under which Medical Experimentation on humans could be lawfully conducted. The Nurenburg Code is the result of The Nuremberg Military Tribunal's at the end of Word War II. During the war very gruesome medical experiments were carried out on prisoners of war and the Nuremburg Code sought to put an end to the misuse of medical experimentation. First and foremost, the

Evelyne Shuster, Ph.D., wrote and article on the Nuremberg code which appeared in the New England Journal of Medicine. Dr. Shuster explains "voluntary consent". She writes:

This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force,

fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the

experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon **each individual who initiates**, **directs or engages in the experiment**. It is a personal duty and responsibility which may not be delegated to another with impunity.⁴³ (Emphasis Added)

Anyone who asks you to get a Covid-19 vaccine or offers you a Covid-19 vaccine is engaging in medical experimentation. The legal responsibility of following **all conditions of the Nuremberg Code** rests with those who are asking you to get a vaccine or offering you a vaccine. As far as I

People are beginning to call for those mandating vaccines to be placed in Nuremberg Tribunals for crimes against humanity. Currently, there are no Statute of Limitations for Nuremberg Code violations.⁴⁴

Vaxxchoice.com also has a lengthy report on how to file a private Criminal Complaint for Nuremberg Code violations. If OSHA issues a rule for employer vaccine mandates, it probably won't take long for a judge to issue an injunction. Charlie Kirk of Turning Point USA, speaking about vaccine mandates, announced: "As soon as OSHA issues this rule we will sue, we will win."45 Other companies have made similar announcements. Twenty-four Attorneys Generals from Republican states have banned together to fight the proposed vaccine mandates for large employers. A seven-page letter was sent to president Biden stating lawsuits will be filed if the proposed mandates are implemented by OSHA.46

As of this writing, September 29, 2021, OSHA has made no rule mandating the Covid-19 vaccine. Legal experts say it would be illegal without a law authorized by Congress and signed by the president. Many legal experts believe it would still be unconstitutional. So do I.

Black Cumin Seed

A controlled scientific study was done in Pakistan on the ability of Black Cumin Seed (Nigella sativa seed) and Honey to treat Covid-19. Religious Objection Exemptions
